Subject: Grant of conditional permission to Madhav Homoeopathic Medical College and Hospital, Madhav Hills, NH 27, Opp. Banas River Bridge, P.O. - Bharja (Abu Road), Tehsil- Pindwara, Dist.-Sirohi, Rajasthan for admission in UG (BHMS) course with 60 seats for the academic session 2020-21-reg.

Sir,

I am directed to refer to the provisions prescribed under Section 12C of the Homoeopathy Central Council Act, 1973 and regulations made thereunder and Ministry's policy for the academic year 2020-21, In order to verify the compliance of availability of standards by the College, the Board of Governors to CCH has examined the documents submitted by the college authority for the admissions for the academic year 2020-21 in BHMS course of Madhav Homoeopathic Medical College and Hospital, Madhav Hills, NH 27, Opp. Banas River Bridge, P.O. - Bharja (Abu Road), Tehsil- Pindwara, Dist.-Sirohi, Rajasthan, and furnished recommendation vide its letter No. F. No. 15-8/2020-CCH (Visitation Matter) 3469 dated 02.11.2020 as under:-

"Recommended for allowing admission in BHMS Course for the session 2020-21 with the intake capacity of only 60 seats in existing UG (BHMS) course, due to insufficient teaching staffs (as not a single guest faculty available against 12).

The Committee also recommended to apprise the Ministry about ineligible teachers. Details of ineligible teachers are as under:

1. Dr Gayatri Bhat (Lecturer, OBG) - Relieved from the Institute from 17/12/2019.

2. Dr Rasika Ravindra Kumar (Lecturer, OBG) - Not considered eligible as sample signature for teacher code not matching with joining and provided affidavit.

3. Dr Rakesh Ram Sharma (Reader, Community Medicine) - has relieved from the college.

4. Dr Deshmukh Mangesh (Lecturer- Community Medicine) - Not considered eligible as sample signature for teacher code is not matching with joining and provided affidavit.

Further, college website is not updated and the college has not complied with the provisions of Employee's Provident Funds & Miscellaneous Provident Act 1952 & ESI Act, 1948 and relevant Rules and Regulations."

2. The college was granted an opportunity of hearing through Video-Conferencing to present their case on 25.11.2020. The college authority presented their submissions against the deficiencies conveyed. These submissions are not sufficient enough to prove the fulfilment of the criteria required for grant of permission for admission in 100 UG seats.

2. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC (MSR) Regulations, 2013, recommendations of the Board of Governors to CCH, conditional permission of the Central Government is hereby granted to Madhav Homoeopathic Medical College and Hospital, Madhav Hills, Nh. 27, Opp. Banas River Bridge, P.O. - Bharja (Abu Road), Tehsil- Pindwara, Dist.-Sirohi, Rajasthan for continuing admissions in BHMS course during the academic year 2020-21 with intake capacity of 60 UG seats only, with the condition to fulfil all deficiencies as reflected at para 1.

4. It is further informed that, minimum 15% of undergraduate seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counselling for seats under All India quota shall be conducted by respective counselling Authority of State / UT Government as designated by the Central Government vide letter F. No. L. 11011/02/2020-E- (1) dated 26.10.2020 for A.Y. 2020-21 and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the students admitted thereunder.

5. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under HCC Act & Regulations made thereunder. Discrepancies, if any, may be immediately brought to the notice of CCH and the Central Government.

6. The College shall comply with the provision for providing EPF and ESI facilities to the teaching, Non-teaching staff of the College/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

7. The compliance of the full requirements of the HCC (MSR) Regulations 2013 made up to 31st December 2020 will be submitted by the College to the CCH, which will be verified for considering permission for admission during the Academic Year 2021-22.
