Sir/Madam,

With reference to the above cited subject, and referred letter the undersigned is directed by the competent authority to convey as under:

- “1. The college submission as an appeal with documents which have been carefully examined by the Commission and observed that all the deficiencies are rectified except that acquittance roll submitted is without revenue stamp.
2. Now, THEREFORE, the Commission has decided to issue permission for 1<sup>st</sup> BHMS course with intake capacity of 100 UG seats for Madhav Homoeopathic Medical College and Hospital Madhav Hills, Post-Bharja, Tehsil-Pindwara, Opp. Banas River Bridge Toll NH-27, Abu Road, Sirohi – 307026, Rajasthan for the academic session 2022-23.
3. All admissions in Under Graduate (BHMS) course shall be through ‘National Eligibility Entrance Test (NEET)’ only. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and will invite penalty as may be decided will be imposed.
4. The counselling for 15% seats under All India quota shall be conducted by respective counselling Authority of State/ UT Government as designated by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State / UT. 100% Under Graduate seats of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted shall be informed to the Medical Assessment and Rating Board for Homoeopathy immediately after the process of admission is completed.


5. Accordingly, the college representation dated 10.12.2022 to Commission against order of MARBH vide letter dated 12.11.2022 stands disposed of”.
